

# PBC & Camp Encounter Waterfront Waiver

## ACKNOWLEDGEMENT OF RISK AND HOLD HARMLESS AGREEMENT PLEASE READ

I hereby acknowledge that I and my minor children have voluntarily chosen to use Peniel Bible Conference, Inc 's (also known as Camp Encounter, Encounter Camp and Retreat Center and, or Teen M@tters; hereinafter called "PBC") lake waterfront, in ground pool, and watercraft made available by PBC.

I/ and my minor children understand the risks involved in using the waterfront, pool area and watercraft. I recognize that waterfronts, pools and watercraft and their use involves risk of minor bodily injury, severe bodily injury, and death. Furthermore, I recognize that using waterfronts, pools and watercraft involve activities and risks incidental thereto, including but not limited to, unpredictable weather, water hazards, the reckless operation of other watercraft, limited availability of medical assistance and the possible reckless conduct of other individuals. I/and my minor children are voluntarily using the pool, waterfront and watercraft with the knowledge of the risks involved and hereby agree to accept any and all inherent risks of property damage, bodily injury or death. I/and my minor children understand that there is not always a lifeguard on duty and that I and my minor children are using the waterfront, pool and watercraft at our own risk. We agree to adhere to the rules and by signing below do claim that we have read and understand the waterfront rules at PBC.

In consideration of my/ and my minor children's use of the waterfront, pool and watercraft and to the fullest extent permitted by law, I/ and my minor children agree to indemnify, defend and hold harmless PBC, their trustees, officers, directors, employees, agents, volunteers, assigns from and against all claims arising out of or resulting from my/ and my minor children's use of the waterfront, pool and watercraft. "Claim" as used in this agreement means financial loss, claim, suit, action, damage, or expense, including but not limited to attorney's fees, attributable to bodily injury, sickness, disease or death, or injury to or destruction of tangible property including loss of use resulting therefrom. In addition, I hereby voluntarily hold harmless PBC their trustees, officers, directors, employees, agents, volunteers and assigns from any and all claims, both present and future, that may be made by me, my family, estate, heirs or assigns arising from use of the waterfront, pool and/or watercraft.

I hereby expressly agree to indemnify, defend, and hold harmless PBC, their trustees, officers, directors, employees, agents, volunteers and assigns for any and all claims arising out of or incident to my/ or my minor children's use of the waterfront, pool and watercraft. I have read and understood this acknowledgement of risk and hold harmless PBC and Encounter Camp and Retreat Center.

## Pool Rules

### Peniel Visitors & Registered Guests

### Peniel Visitors & registered guests

**MUST follow all rules as listed below.**

Remember . . . .

- Children under the age of 16 must be accompanied by and adult.
- 18 year old adults can only accompany 2 children under the age of 16.
- ANY accidents in the pool MUST be reported to the office immediately
- Any injuries in the pool MUST be reported to the office immediately

### Peniel Camp Swimmers: Must enter swimming area using "Buddy Board"

YOU must follow Lifeguard's direction at all times.

RED Swimmers must stay to shallow. Blue Swimmers have full use of pool

NO hanging on Buoy line

NO running on deck

NO Diving

NO Jumping in shallow

NO Floatation devices allowed.

NO horse play (Wrestling,

Pushing, Chicken fights)

NO Food allowed, NO Glass bottles (Plastic water bottles permitted)

NO holding breath contests (hypoxia)

YOU MAY have fun, cool off, relax, swim & play!

In the event of Thunder or lightening ALL swimmers must IMMEDIATELY leave the water for a minimum of 30 minutes. Swimmers may return if no other signs of thunder or lightening occur within that 30 minutes.

## WARNING NO LIFEGUARD

TWO OR MORE ADULTS 18 YEARS OR OLDER  
MUST BE PRESENT WHENEVER THIS  
SWIMMING FACILITY IS IN USE, WITH AT LEAST  
ONE ADULT ON THE POOL DECK.

CHILDREN LESS THAN 16 YEARS OF AGE MUST AT  
ALL TIMES BE ACCOMPANIED BY AN ADULT  
RESPONSIBLE FOR THEIR SAFETY AND BEHAVIOR  
WHILE AT THE BATHING FACILITY.
